2. This form is for a Substantial Shareholder(s)/Unitholder(s) to give notice under section 135, 136, 137, 137J (as applicable to sections 135, 136 and 137) or 137U (as applicable to sections 135, 136 and 137) of the Securities and Futures Act (the "SFA").

While Form C will be attached to the announcement template, it will not be disseminated to the public and is made available only to the Monetary Authority of Singapore (the "Authority").

Each of the executors of the Estate of Lee Fee Huang (the "Estate"), being Lee Sze Leong, Lee Sze Siong, Lee Sze Hao and Lee Yit was deemed to have an interest in the 1,802,000 shares in Listed Issuer registered in the name of the Estate.

With the transfer of the 1,802,000 shares in Listed Issuer from the Estate to its named beneficiaries, Lee Yit's deemed interest in such shares as an executor of the Estate ceased.

Prior to the demise of Lee Fee Huang and the transfer of such shares pursuant to his will, F.H. Lee Holdings (Pte) Limited was accustomed to act in accordance with the directions, instructions or wishes of certain members of the Lee family, including Lee Yit. Accordingly, Lee Yit was deemed to have an interest in the 141,662,246 shares in Listed Issuer registered in the name of F.H. Lee Holdings (Pte) Limited.

Following the demise of Lee Fee Huang and a change in the internal arrangement within the Lee Family, F.H. Lee Holdings (Pte) Limited is no longer accustomed to act in accordance with the directions, instructions or wishes of Lee Yit. In addition, Lee Yit does not on her own hold 20% or more of the votes attached to the voting shares of F.H. Lee Holdings (Pte) Limited.

Accordingly, following the aforesaid transfer of shares, Lee Yit has ceased to have a deemed interest in the 141,662,246 shares in Listed Issuer registered in the name of F.H. Lee Holdings (Pte) Limited.
